**Subject:- Labeling of MRP of pre-packaged commodities after Implementation/reduction of GST reg.**

Kindly attention of all member of all the member of Trade/Industry/Trade Association /Chambers of commerce and Industry /RAC and all other concerned is invited to the letters bearing F.No WM-10(31)/2017 dated 04.07.2017 and 29.09.2017 issued by the Ministry of Consumer Affairs, FOOD and Public Distribution, Department of Commerce Affairs, Legal Metrology Division, the Central Government permitted manufacturers or packers or importers of pre-packages commodities to declare the changed retail sale price (MRP) on the unsold stock manufactured /packed / imported prior to 1<sup>st</sup> July 2017 after duty accounting for /adjusting input credit, in addition to the existing retail sale price (MRP), up to 31<sup>st</sup> December, 2017 by way of stamping or putting stickers or on line printing.

2. Further, as the rates of GST were reduced, in terms of the permission granted vide letter No. WM-10(31)/2001 dated 16.11.2017 issued by the Ministry of Consumer Affairs, Food and Public Distribution, Department of Commerce Affairs, Legal Metrology Division, to affix an additional sticker or stamping or online printing for declaring the reduced MRP on pre -packaged commodities including in unsold stocks manufactured/ packed/imported after 1<sup>st</sup> July, 2017 where the MRP would reduce due to reduction in the rate of GST post 1<sup>st</sup> July, 2017.

3. The director of Legal Metrology has extended the permission so granted under the above mentioned letters till 31<sup>st</sup> March, 2018.
