Subject: - Partial modification in the Standing Order No. 02/2018-19 dated 27.06.2018 on "Manual filing and processing of refund claims on account of inverted duty structure, zero-rated supplies, deemed exports and excess balance in electronic cash ledger" - reg.

Kind attention is invited toward the Standing Order No. 02/2017-18 issued by this office vide F. No. I(Gen)19-11/GST/Standing Order/18-19/3909-3924 dated 27.06.2018 on the captioned subject in the lines of Circular No. 17/17/2017-GST dated 15.11.2017 and 24/24/24/2017-GST dated 21.12.2017 issued by the Central Board of Excise and Customs, New Delhi.

2. This office has received reference from the Commissioner of State Tax Department regarding difficulties being faced by the Nodal Officers of State Tax in communicating refund sanction orders pertaining to Pithampur Area to respective Nodal Officers of Central Tax. It was informed that since three Nodal Officers have been appointed by the Central Tax for the Pithampur Area, Nodal Officers of State tax find it difficult to identify the proper Nodal Officer of Central Tax for sending the refund sanction orders and it was desired that only one Nodal Officer may be appointed for Pithampur Area.

3. In view of the above, to ensure smooth and timely processing of payment of refunds to the tax payers, it has been decided that for receiving refund sanction orders from the State tax Department pertaining to Pithampur/Dhar District, the Deputy / Assistant Commissioner of the CGST Division Pithampur-2 is to act as the Nodal Officer in light of Circular No. 17/17/2017-GST dated 15.11.2017 and 24/24/2017 dated 21.12.2017 for all the three CGST Divisions of Pithampur/Dhar District. The Nodal Officer so nominated will receive refund sanction order from State Tax and send it to the respective proper sanctioning Authority of the three CGST Divisions of Pithampur. Particulars of the Nodal Officer are as in the following table:

However, for the purpose of sending any refund sanction order to SGST authorities, the respective sanctioning authority of Central Tax (i.e. DC/AC of Division Pithampur-I/II/III) will continue to act as Nodal Officers and will directly forward refund orders to their counter parts of State tax.

4. The contents of the Standing Order No. 02/2017-18 issued by this office vide F. No. I(Gen)19-11/GST/Standing Order/18-19/3909-3924 dated 27.06.2018 are modified to the above extent.
