

2. In light of the "Ease of Doing Business" initiative by Government of India and in order to reduce dwell time and increase speedy clearance of cargo, the procedure of clearing the goods is further simplified. Henceforth, the out of charge of the goods will be given by the officers posted at ICD's under this Commissionerate i.e. ICD Pithampur, ICD Kheda and ICD Ratlam without insistence on Delivery order.

3. After payment of duty, the importer/CHA shall bring copy of B.E. for registration alongwith duly self-attested copy of Bill of Lading.

4. As soon as the goods are registered for examination, the Customs Officer posted at Import Shed will examine the goods in case where examination has been prescribed and will check container No. & Seal in case of RMS facilitated Bill of Entry. If the goods are found to be as per declaration, the out of charge of the goods will be given immediately without insistence on or waiting for Delivery Order.






